### **Article 1 Introductory Provisions**

1. This Directive applies to foreign students of the Faculty of Technology (further only "FT") who study in full-time Master's Degree programmes taught in English. These foreign students ("self-financed") are classified in category 6 in the IS/STAG information system.
2. This Directive supplements the Scholarship Programme of Tomas Bata University in Zlín (further only "TBU").
3. The Extraordinary Scholarship is not guaranteed. The final decision comes under Dean's authority.

### **Article 2 Conditions for Extraordinary Scholarship Acquisition**

1. Entitlement to an Extraordinary Scholarship comes into force in the month of the student's enrolment for the second academic year of his/her studies for the purpose of supporting their succeeding studies at FT TBU.
2. The Extraordinary Scholarship is granted after the student's tuition fee is paid on time. Should the student fail to pay his/her tuition fee on time, entitlement to the Extraordinary Scholarship will expire.
3. In order to receive the Extraordinary Scholarship, the student has to pass at least 85 percent of the prescribed credits from the previous study period at FT TBU. If the student fails to fulfil this condition, the Extraordinary Scholarship will be canceled.

### **Article 3**

#### **Extraordinary Scholarship Scheme to Support of Studies at the Faculty of Technology, Tomas Bata University in Zlín**

1. In order to receive the Extraordinary Scholarship, the student has to submit an application to the Dean of FT TBU after the student has enrolled for the second academic year of study.
2. The amount of the Extraordinary Scholarship is determined by the Dean of FT. The maximum amount of the scholarship is up to 50 percent of the student's tuition fee which the student paid for that specific academic year.
3. The whole amount of the Extraordinary Scholarship will be paid at once after the Dean's decision.
4. Payment of the Extraordinary Scholarship will expire upon the student's graduation or termination of studies.
